## REGULAR MEETING OF THE CITY COUNCIL CITY OF CALEDONIA, MINNESOTA Monday, December 11, 2006

CALL TO ORDER: Following due call and notice thereof, Mayor Morey called the meeting to order at 7:00 p.m. in the Council Room, City Hall.

ROLL CALL: Members present: Mayor Michael J. Morey; Council Members Paul Fisch, Randi Vick, Gary Klug and Robert Standish. Members absent: None. Consultants and City staff present: Michael Gerardy, Dan Schwirtz, Chuck Gavin and Robert L. Nelson. Visitors present: Noel Brenza, Loretta Knutson, Janene Hosch and Jane Palen, Report.

CONSENT AGENDA: Following brief discussion, a motion was made by Member Klug, seconded by Member Standish, to approve the Consent Agenda items, stated below. All members voted in favor and the motion was declared carried.

A. MINUTES OF PAST MEETINGS: To approve the minutes of the Regular Meeting held Monday, November 27; and Special Meetings of December 4 (5:00 p.m.), December 4 (6:00 p.m.) and December 7, 2006, as presented.

## B. 2007 LICENSES

- 1. LIQUOR / CLUB LICENSES: Contingent upon completing application forms and payment of fees, to approve Liquor Licenses for Beverly Rud (Bev's Bar), Richard Schulze (The Ranch), David and Janice Kutina (Starlite Bowling Center) and Dave and Kris Wedl (Good Times Bar & Pizza), and a Club License to American Legion Post 191 (American Legion Club).

## D. DONATIONS

- 1. To accept a pass-thru donation from the Arlin C. Faulk Foundation in the amount of \$1,000 and pay it over to the Caledonia Balloon Rally Committee.
- 2. To accept a donation from AgStar Financial Services in the amount of \$2,400 and apply it to the purchase of Minitor V Pagers for the Caledonia Volunteer Fire Department.
- E. TEMPORARY RETAIL ON SALE 3.2 MALT LIQUOR LICENSE: To approve a temporary Retail On-Sale 3.2 Malt Liquor License for Caledonia Founder's Days, Inc., for 1 day, being the 26<sup>th</sup> of January, 2007, to conduct sales at the City of Caledonia Auditorium, 219 E. Main Street.

PUBLIC HEARING: A Public Hearing had been advertised for 7:05 p.m. to accept testimony on the proposed, updated Comprehensive Plan, then follow with adoption of the plan. Because of the outcome of a Special Meeting held December 7, calling for further discussion meetings on the Comprehensive Plan with Houston County, Caledonia Township and Mayville Township representatives, the Public Hearing will be rescheduled at a later date. (There were no persons in attendance this evening to speak to the Comprehensive Plan.)

#### VISITORS AND COMMUNICATIONS

- A. ADMINISTRATIVE COORDINATOR TOPICS:
  - 1. ADDITIONAL STREET LIGHT POLES WRAPS: Mike Gerardy and Noel Brenza informed the Council that a notice of street light pole wraps were available at a sale price of \$85 instead of \$120 per wrap. Since the original plan was to order half of the desired wraps this year and half next year, Mrs. Brenza

recommended purchase of next years supply at this time for the reduced fee of \$35 per wrap. Approximately 16 or 17 more wraps are necessary. Following discussion, a motion was made by Member Klug, seconded by Member Fisch, to authorize the immediate purchase of 17 additional street light pole wraps for an approximate cost of \$1,450 to be financed through the General Fund. All members voted in favor and the motion was declared carried.

- 2. ELECTRIC DEPARTMENT BUILDING: Mr. Gerardy reported that rain saturated the area of the concrete floor causing a delay in the concrete work. He reported that discussion with the contractor resulted in a proposal that the concrete work be delayed until the superstructure contractor completed construction of the upper portion of the building until it was fully enclosed and could be heated to dry out the base. Travis Bernau, concrete contractor, was concerned; however, that such extension of the concrete portion of the work would result in liquidated damages since the concrete placement would not be finished until after the contract completion date. Mr. Gerardy said he would investigate this proposal with Caledonia Lumber Company, the contractor for the superstructure portion and report back to the Council at a later time.
- B. FARMER'S MARKET: Loretta Knutson and Janene Hosch inquired of the Council whether or not the City would have objection to having a Farmer's Market operated on Saturday mornings from approximately 8:00 a.m. until Noon with the prospective site being by the Eitzen State Bank property on the west side of STH 44/76. They anticipated the market would operate every Saturday through the harvest season. The Council indicated by general consensus that the City would have no objection to conducting a Farmer's Market on the private property described.
- C. FIRE DEPARTMENT ISSUES: Chuck Gavin, Fire Chief and Dan Schwirtz, Assistant Chief, proposed to the Council that the Fire Relief Association, using its Gambling Operation Funds, wished to purchase items for the Fire Department, including equipment for the recently acquired Ladder Truck and would make a donation to the City from the Gambling Funds in the same amount as cost of purchases. They submitted a list of items, considered for purchase totaling approximately \$8,000. Following discussion, a motion was made by Member Fisch, seconded by Member Klug, to authorize the proposed purchases and accept the donation from the Relief Association Gambling Funds in payment to the City. All members voted in favor and the motion was declared carried.
- D. FIRE DEPARTMENT DNR GRANT APPLICATION: The Council was informed that Fire Department officers had completed a Grant Application to the Department of Natural Resources, requesting approximately \$2,000 toward the purchase of approximately 10 pagers for the Fire Fighters. This grant requires a 50 % match from the City, thus being a total anticipated purchase price of \$4,000. Following discussion, a motion was made by Member Fisch, seconded by Member Klug, to approve the application for the DNR Grant in the amount of \$2,000, involving a \$2,000 match from the City, and authorizing Mayor Morey to sign on behalf of the City. All members voted in favor and the motion was declared carried.

#### **OLD BUSINESS**

- A. COMPREHENSIVE PLAN: Clerk Nelson reminded the Council of their original proposal earlier in the year to pay the cost of the Comprehensive Plan consulting fees during calendar year 2006. He informed the Council that Shannon Sweeney, David Drown Associations, said the anticipated final billing at this time was \$23,000. Following discussion, a motion was made by Member Vick, seconded by Member Standish, to authorize payment to David Drown Associates in the amount of \$23,000 for their consulting fees on the update of the Comprehensive Plan. All members voted in favor and the motion was declared carried.
- B. AMBULANCE DEPARTMENT: At this time the Council generally discussed the plan for appointment of a new Ambulance Service Director. Among items to be accomplished were a new Job Description for which Clerk Nelson said he had contacted some surrounding ambulance services requesting copies of the job description for their director. With regard to a meeting held with ambulance attendants on December 5, the committee (Morey and Fisch) reported that the ambulance attendants encouraged the hiring process to be completed as soon as possible and recommended that the new director be appointed from current active members of the ambulance service. The Council Committee, however, held the opinion that the position should be advertised. Another meeting was planned with the ambulance attendants on December 19 to review a draft of the job description and discuss other issues of the appointment process.

## **NEW BUSINESS**

- A. FLU VACCINATIONS: Clerk Nelson informed the Council that the Houston County Public Health Nursing Service reported having excess flu vaccination supplies. The Nursing Service asked if the Council wished to offer vaccinations to Firefighters or Ambulance Attendants at a fee of \$20 per dose. Following brief discussion, the Council decided by general consensus not to become involved in voluntary vaccinations.
- B. MOSQUITO CONTROL: Clerk Nelson submitted a billing from David Geske, LaCrosse Mosquito Control Unit, for services performed throughout the summer of 2006 in the amount of \$1,525. A motion was made by Mayor Morey, seconded by Member Standish, to authorize payment to Mr. Geske in the amount of \$1,525. All members voted in favor and the motion was declared carried.

#### **CLERK'S REPORT**

- A. POLICE DEPARTMENT: Enclosed with the Agenda was the Police Officer Activity List and Summary Report for November 2006.
- B. EMPLOYEE TIME RECORD: Enclosed with the Agenda was the Employee Time Record for pay period November 20 December 3, 2006.
- C. ASSESSMENT FEE: Enclosed with the Agenda for informational purposes only was the final statement for assessment fees from Houston County. County Assessor Dibbing confirms that fees for 2007 and thereafter shall be levied directly by the County and not billed through lower level sub government.

- D. PRESS RELEASE: Enclosed with the Agenda was a press release prepared by Tri-County Electric Cooperative regarding the power outage on December 7, 2006.
- E. THE WHEEL: Enclosed with the Agenda were copies of The Wheel from the Rotary Club.

RECESS: There being no further business at this time, but with the understanding that some additional issues will soon require Council attention; Mayor Morey recessed this meeting to be continued on December 14, following the continuation of the Truth -N - Taxation Meeting.

# CONTINUED MEETING OF THE CITY COUNCIL CITY OF CALEDONIA, MINNESOTA Thursday, December 14, 2006

CALL TO ORDER: Following due call and notice thereof, Member Fisch called the meeting to order at 6:02 p.m. in the Council Room, City Hall.

ROLL CALL: Members present: Council Members Paul Fisch, Randi Vick, Gary Klug and Robert Standish. Members absent: Michael J. Morey. Consultants and City staff present: Stephanie Mann, Mike Gerardy and Robert L. Nelson. Visitors present: None.

#### **BUSINESS ITEMS**

- A. 2007 BUDGET: Following the meeting of December 4, investigation was made of the proposed changes to the draft budget submitted by City Accountant Stephanie Mann with a final tally revealing that the budgeted revenues exceeded expenditures by \$154,280. Based on discussions with department heads and staff since that meeting, recommendations were made to delete the proposed certificate of indebtedness for a revenue amount of \$52,400 and to complete the top portion of the salt shed scheduled for construction in 2007 for an added expense of \$24,000. Other changes included elimination of a generator for an estimated cost of \$5,000 and other miscellaneous changes resulting in a subtotal of approximately \$72,230 excess revenues over expenditures. The Council planned that \$50,000 of that amount would be dedicated to the cash deficiency of the General Fund with \$22,230 remaining to be allocated to undesignated expenditures.
- B. 2006 LEVY: Ms. Mann commented that the proposed 2006 Levy was advertised in September as \$434,585 a \$39,508 (10%) increase over the 2005 Levy of \$395,077. Based upon the anticipated excess revenues, comment was made that an 8% increase may be more reasonable than the proposed 10% Levy.

ADJOURNMENT: Following discussion, Member Fisch determined that action on the 2007 Budget and 2006 Levy would be taken in the following continued meeting rather than this continued Truth-N-Taxation Meeting, therefore a motion to adjourn was made by Member Standish and seconded by Member Vick. All members present voted in favor, the motion was declared carried and the meeting then adjourned at 6:41 p.m.

CALL TO ORDER: Following due call and notice thereof, Member Fisch called the meeting to order at 6:42 p.m. in the Council Room, City Hall.

ROLL CALL: Members present: Council Members Paul Fisch, Randi Vick, Gary Klug and Robert Standish. Members absent: Michael J. Morey. Consultants and City staff present: Mike Gerardy, Chuck Gavin, Matt Hoscheit and Robert L. Nelson. Visitors present: None.

## **BUSINESS ITEMS:**

- A. 2007 BUDGET: Based upon discussion at the earlier Truth-N-Taxation Continued Meeting, a motion was made by Member Standish, seconded by Member Klug, to incorporate discussed changes and adopt a 2007 Budget for the General Fund in the amount of \$1,929,988. All members voted in favor and the motion was declared carried.
- B. 2006 TAX LEVY: Based upon discussion at the earlier Truth-N-Taxation Meeting, a motion was made by Member Klug, seconded by Member Vick, to set the Tax Levy at an amount of \$426,683, being an 8% increase or a \$31,606 increase over the 2005 Levy. All members present voted in favor and the motion was declared carried.
- C. LAWFUL GAMBLING: A motion was made by Member Klug, seconded by Member Standish, to approve an application for Exempt Permit, submitted by the Knights of Columbus Council 1198, to conduct a raffle at the Caledonia High School, 825 North Warrior Avenue, on March 16, 2007, also waving the waiting period. All members presented voted in favor and the motion was declared carried.
- D. PARTIAL PAYMENT REQUEST: Michael Gerardy, Administrative Coordinator, recommended approval of a partial payment request in the amount of \$27,260 to Bernau Concrete, LLC, for work performed on the Electric Department Garage foundation. The requested amount represents 47% of the total bid cost, being in substantial compliance with the terms of the special provisions. Mr. Gerardy also discussed extending the contract completion date because of delays of inclement weather and damages that weather made to the foundation soils in the area of the proposed concrete floor. Following discussion, a motion was made by Member Vick, seconded by Member Klug, to approve the partial payment request in the amount of \$27,260. All members present voted in favor and the motion was declared carried. No action was taken on extending the contract completion date, but discussion included the fact that the Council was not bound to assess liquidated damages. Liquidated damages are to be assessed only if project delay is deemed to be caused by reasons under the contractors' control.
- E. PROPERTY TAX ABATEMENT DEVELOPMENT AGREEMENT: Clerk Nelson reported to the Council that Joyce Iverson, EDA Director, had presented the Abatement Development Agreement with the comment that Attorney's for Hutton Company were still attempting negotiation of some items, but the County Attorney and City Attorney were rejecting those requested changes. The belief is that the document, as stated, will be the final addition. Following brief discussion, a motion was made by Member Fisch, seconded by Member Klug, to approve the Property Tax Abatement Development Agreement between the City Of Caledonia, Houston County and Hutton Partners, LLC, contingent upon their being no further changes to the Property Tax Abatement Development Agreement, annotated at the top of the pages as the December 11, 2006 revision. All members present voted in favor and the motion was declared carried.
- F. ELECTRICAL POWER RELIABILITY: Chuck Gavin, Fire Chief and Matt Hoscheit, Firefighter, informed the Council of their efforts to obtain generators and restore heating capabilities to senior citizen apartment complexes during the power outage caused by a blowout at the downtown substation on December 7. They recommended that the City wire certain buildings for hook-up to a generator in the event of future outages. Brief discussion was held on the differences and characteristics of permanently mounted generator and portable generators. They were informed that a dollar value had been included in the 2007 Budget to install switches on the fire barn / city hall building.
- G. WAGES: Member Fisch reported that the Wage Committee (Morey & Fisch) had prepared recommendations for wage increase for certain employees, who are not members of a labor association. Following discussion of the Committee recommendation, a motion was made by Member Fisch, seconded by Member Klug, to approve the following wage rates for calendar year 2007. All members presented voted in favor and the motion was declared carried.
