## SPECIAL MEETING OF THE CALEDONIA CITY COUNCIL COUNCIL CHAMBERS, CITY HALL CALEDONIA, MINNESOTA December 21, 2023

CALL TO ORDER: Following due call and notice thereof, Mayor DeWayne "Tank" Schroeder called the meeting to order at 6:00p.m. in the City Hall Council Chambers.

## OLD BUSINESS:

a. <u>Grove Marshall Street and Utility Reconstruction Assessments:</u> City Clerk/Administrator Dickson presented a staff report on the options available for the Grove Marshall Street and Utility Reconstruction Assessments. Mayor Schroeder recommended following the advice of City consultants and allowing the appeal process to continue. Member Ninneman expressed concern over the 20% assessment figures and the legal process. City Engineer Matt Mohs outlined a different assessment formula to cover underground utilities and removing street costs from assessments. Member Stenzel asked about tax increases to cover project costs. Sever funding proposals were discussed including a local sales tax option and citywide assessments. Members of the public asked questions related to financing, taxation, special benefit, and the assessment process. Motion made by Member Ninneman to Amend the Assessment Roll to a 10% Assessment. Motion seconded by Member Fitzpatrick. Motion passed 3-0 with Mayor Schroeder and Member Klug voting in the negative.
