 - C. MMUA CIP Assessment: The public utilities board has set new standards for conservation improvement programs of electric utilities. MMUA has made an assessment for lobbying and informing municipal utilities of their obligations with regard to the conservation improvement program. The City of Caledonia's assessment is \$417 and is includable in the funds we claim for the conservation improvement program.
