B. Electric Department Issues

1. Citizen Request to Bury Overhead Wires: There has been discussion for many years of either relocating a utility pole or perhaps burying the overhead wires underground at the location of 309 West South Street. We will describe this in detail for the Council at the meeting.

2. Purchased Meter Testing Bench: Mr. Blocker will describe for the Council the need for a meter testing bench at the electric department and request authorization to purchase according to the costs itemized on Addendum #2. There are miscellaneous, minor expenses associated with this for which he shall request authorization to spend up to \$2,000.

3. Committee Clarification: With regard to the Electric Department, there is a question whether or not there should be 2 or 3 employees for the electric department. There is also the issue of a council committee interviewing prospective employees for positions in the City for all departments. The question is whether the issue of the number of employees in the electric department should first be resolved by the committee for the enterprise funds (Murphy and Lemke) before interviews would be conducted by the governmental committee (Perry and Murphy).

4. Electrical Rate Power Cost Adjustment (PCA): Tri-County Electric Cooperative has been charging a whole sale power cost adjustment to the City of Caledonia which in January costs the City an additional \$14,489.89 above and beyond the normal wholesale rates. Tri-County Electric recommends that the City of Caledonia also establish a power cost adjustment flexible rate which would change every month according

to the charges made by Tri-County Electric or a calculated charge for the City of Caledonia based upon Tri-County's rate. I will explain this in greater detail at the meeting, but do request the Council authorize a new charge of a power cost adjustment which will vary monthly, depending upon the charge made to the City by Tri-County Electric in its wholesale rate. 5. Predicted Wholesale Electrical Rate Change: Tri-County Electric Cooperative gave notice to the City that there will be a 10% to 13% wholesale rate increase effective with the beginning of the next contract year, May 1, 2009. When PowerPlus Engineers Tom Nigon and Chuck Gustafson were visiting Caledonia a few days ago, I discussed this anticipated rate with them, asking if we needed to have engineering expertise to change our rates or if we might simply increase our kilowatt hour charge for each of our electrical classifications by a percent. At that time, they appeared to think it would be sufficient if we increased our kilowatt charge by a percent amount. Today, however, I received an e-mail from Tom Nigon proposing that we could have an engineering calculation of the anticipated rate adjustment to make up for the increased wholesale costs for an engineering fee not to exceed \$1,000. Is the Council satisfied if we do the calculations ourselves for a percentage approved by the City Council at our recommendation? Addendum #4

VII. New Business
