ORDINANCE NO. 2016-001

AN ORDINANCE AMENDING CHAPTER 111 OF THE CITY CODE TO EXPRESSLY AUTHORIZE THE CITY TO ISSUE WINE LICENSES

The City Council of the City of Caledonia, Minnesota hereby ordains as follows:

SECTION 1. That Section 111.55 of the City Code is amended by adding the words that are underlined deleting the following words that are struckthrough and adding the following words that are underlined, to read as follows:

§ 111.55 ISSUANCE OF OTHER LICENSES.

(A) *On-sale licenses for the sale of intoxicating liquor.* The Council may issue in its sound discretion on-sale intoxicating liquor licenses to a club~~s~~ under M.S. § 340A.404, Subd. 1(4), as it may be amended from time to time. If the voters have authorized their issuance at a special election called for that purpose, the Council may issue ~~in~~ in its sound discretion on-sale intoxicating liquor licenses to hotels and restaurants. The number of on-sale licenses issued under this section is governed by M.S. § 340A.413, as it may be amended from time to time, as limited by the provisions of this chapter. The issuance of these licenses is governed by the provisions of this chapter.


(B) *Off-sale licenses for the sale of intoxicating liquor.* State law does not authorize the issuance of off-sale licenses for the sale of intoxicating liquor by cities which operate a municipal liquor dispensary.

(C) *On-sale licenses for the sale of wine.* The Council may issue in its sound discretion on-sale wine licenses to the following: (1) restaurants that have facilities for seating at least 25 guests at one time and meet the criteria of M.S. § 340A.404, Subd. 5, as it may be amended from time to time, and meet the definition of restaurant in § 111.03 and (2) licensed bed and breakfast facilities that meet the criteria in M.S. § 340A.4011, Subd. 1 and M.S. § 340A.404, Subd. 5, as they may be amended from time to time. The fee for an on-sale wine license established by the Council under the provisions of § 111.23 shall not exceed one-half of the license fee charged for an on-sale intoxicating liquor license. The holder of an on-sale wine license who also holds an on-sale 3.2 percent malt liquor license is authorized to sell malt liquor with a content over 3.2 percent (strong beer) without an additional license.

(D) *On- and off-sale 3.2 percent malt liquor licenses licenses for the sale of 3.2 percent malt liquor.* The Council may issue 3.2 percent malt liquor licenses in its sound discretion as provided in this chapter.

This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

**.. ORDINANCE NO. 2016-002**

**AN ORDINANCE REGULATING NONESSENTIAL WATER USAGE  
UPON CRITICAL WATER DEFICIENCY AS MANDATED BY  
MINN. STATUTE § 103G.291, subd. 1 and 2.**

The City Council of the City of Caledonia, Minnesota hereby ordains as follows:

**Sec. 1-1. Purpose.**

This ordinance establishes water conservation restrictions, and the plan will be in effect at any time the governor declares by executive order a critical water deficiency, pursuant to Minnesota Statutes section 103G.291.

**Sec. 1-2. Definitions.**

*City* means the City of Caledonia

*Clerk* means the Caledonia clerk-administrator or the person assigned duties pursuant to Minn. Stat. § 412.151

*Department* means the Caledonia Water Department.

*Emergency* means the declaration of a critical water deficiency by the governor.

*Irrigation* means the watering of shrubs, trees, sod, seeded areas, gardens, lawns, or any other outdoor vegetation, except outdoor vegetation utilized for agricultural purposes.

*Notification to public* means notification through local media, including interviews and issuance of news releases.

*Public water supplier* means the City or other entity that owns, manages, or operates a public water supply, as defined in Minn. Stat. § 144.382, subdivision 4.

*Reclaimed water* means water collected from rooftops, paved surfaces, or other collection devices and all water utilized more than once before re-entering the natural water cycle.

*Water recirculation system* means any system which enables a user to reuse water at least once prior to returning the water to the natural water cycle.

**Sec. 1-3. Application.**

(a) This ordinance applies to all customers of public water suppliers who own or control water use on any premises.

(b) No person shall make, cause, use, or permit the use of water received from a public water supply for residential, commercial, industrial, governmental, or any other purpose in any manner contrary to any provision in this ordinance.

(c) Mandatory emergency conservation measures shall be implemented based upon the declaration of a critical water emergency by the governor.

**Sec. 1-4. Declaration of critical water deficiency.**

Upon the declaration of a critical water deficiency by the governor, the public water supplier shall immediately post notice of the emergency declaration at the usual meeting place of the City
