REGULAR MEETING OF THE CITY COUNCIL CITY OF CALEDONIA, MINNESOTA

Monday, April 10, 2006

CALL TO ORDER: Following due call and notice thereof, Mayor Morey called the meeting to order at 7:00 p.m. in the Council Room, City Hall.

ROLL CALL: Members present: Mayor Michael J. Morey; Council Members Paul Fisch, Randi Vick, Gary Klug and Robert Standish. Members absent: None. Consultants and City staff present: Michael Gerardy, Joyce Iverson and Robert L. Nelson. Visitors present: Jennifer Jaroski Guinan, Taylor Heard, Tom Molling, Joe Jennings, Todd Pakiz, Harold Kruse and Jane Palen, Reporter.

CONSENT AGENDA: Following brief discussion, a motion was made by Member Fisch, seconded by Member Klug, to approve the Consent Agenda items, listed below. All members voted in favor and the motion was declared carried.

- A. MINUTES OF PAST MEETINGS: To approve the minutes of the Regular Meeting held Monday, March 27, 2006, as presented.
- B. EXEMPT PERMIT: To approve an Application for Exempt, submitted by the Spring Grove Lions, to conduct a raffle on August 20, 2006, at the Houston County Fairgrounds during the annual fair.
- C. SMALL CITIES DEVELOPMENT PROGRAM: To approve a Small Cities Development Program Commercial Loan to Steve and Kathy Nelson in the amount of \$7,039 for a project deemed eligible by the program administrator, Southeast Minnesota Development Corporation, with a total project cost of \$11,732 of which \$4,693 is to be provided by private funds.

VISITORS AND COMMUNICATIONS

- A. PUBLIC HEARING HUTTON COMPANIES: Joyce Iverson, EDA Director, and Taylor Heard, Hutton Companies, reviewed the Hutton Company Application for Tax Abatement in conjunction with construction of a right turn lane on the west side of STH 44/76 to access the entry to the proposed new Dollar Store. Brief review was made of the resolution for adoption of the proposed project. Three bids, documenting cost of the project were presented. Those bids were discussed, considering details including lack of signatures or lack of a grand total sum or the fact that one bid showed calculations of an averaging method of other bids. When there was no further discussion or testimony, Mayor Morey closed the public hearing.
- PUBLIC HEARING FOLTZ/SNODGRASS: At this time a public hearing was conducted on a Zoning Application to construct a pair of residential duplexes (total of 4 units) on Lot 3 and Lot 2, except the north 20 feet, Block 1, in the Fifth Addition to South Winnebago Estates Addition with the layout design placing the buildings perpendicular to South First Street such that the pair of duplexes faced one another, but had a side or end of the building facing South First Street. Michael Gerardy, Zoning Administrator, reviewed the layout of these four residential units, proposed to be sold as condominiums such that each would be separately owned, on the parcel being approximately 140' x 170', allowing less than 6,300 square feet per unit. He noted the narrow, 15' wide proposed driveway, and eluted to a Zoning Ordinance requirement that, "if it is intended that individual buildings of a multiple family dwelling complex be sold separately, provisions shall be made so that each such building to be sold abuts upon a public street." The surrounding property owners indicated they are generally opposed to the layout of this project and would most favorably encourage development of these parcels as single family homes, but otherwise to be at least according to the stipulations in the Zoning Ordinance. When there was no further discussion or testimony, Mayor Morey closed the public hearing and resumed the Regular Meeting.
- C. TAX ABATEMENT APPLICATION HUTTON COMPANY: At this time, the Council further discussed the Tax Abatement Application. A motion was made by Member Klug, seconded by Mayor Morey, to approve and adopt the Resolution for Tax Abatement for an amount not to exceed \$32,000 as the total abatement with the City Of Caledonia amount not to exceed \$12,000, with the understanding this action as a preliminary step with final approvals,

terms and obligations to be described in detail in a development agreement, yet to be drafted. All members voted in favor and the motion was declared carried.

- D. ZONING APPLICATION FOLTZ/SNODGRASS: Based upon the findings that the area of less than 6,300 square feet per unit is less than the prescribed or desired area for a residential property and that the layout positions the buildings with the sides facing the public street rather than the front of the building, which is a unique positioning in a new subdivision and that the layout is contrary to the Zoning Ordinance in that each unit does not abut a public street, a motion was made by Mayor Morey, seconded by Member Fisch, to deny the Zoning Application proposing to construct a pair of duplexes in the South Winnebago Estates Fifth Addition. All members voted in favor and the motion was declared carried.
- E. MINNESOTA ALLIANCE FOR SAFE HIGHWAYS: Jennifer Jaroski Guinan, Field Director, Minnesota Alliance for Safe Highways, encouraged the Council to adopt a resolution to submit to the Minnesota Legislators to protest larger or heavier commercial vehicles being permitted on state roadways. She explained that commercial operators have applied to the legislator to adopt a bill that would increase the weight limits and increase the dimensions or number of accessory units which could be attached to hauling vehicles. These increased weight limits and dimensions would be applied to vehicles traveling on Minnesota Highways, since the Federal Government prohibited any increases in current standards for interstate highways. Discussion alluded to a presentation recently made to the Houston County Board of Commissioners which resulted in a directive from the Commissioners to the Houston County Highway Engineer to draft a letter for submittal to local legislative representatives. The Council concluded by asking for a copy of that letter for examination and chose to not make any resolutions or recommendations at this time.

F. ECONOMIC DEVELOPMENT

- 1. TOURISM AD: Joyce Iverson explained certain community interest in advertising in the magazine *Minnesota Trails*, asking if the Council wished to place an ad for the City Of Caledonia which would be approximately 1/12 page and cost \$162 for a one time ad. *Minnesota Trails* is published four times a year. Following discussion, a motion was made by Member Klug, seconded by Member Standish, to authorize publication of the ad contingent upon other community organizations or business entities participation for the quoted price. All members voted in favor and the motion was declared carried.
- 2. TIF DISTRICT CHANGE: Ms. Iverson reported to the Council that the property to situate the Dollar Store should now be removed from the TIF District since the Council had approved a Tax Abatement Program for the Hutton Company. A motion was made by Member Fisch, seconded by Member Klug, to authorize removal of the parcel of land to be the site for the Dollar Store to be removed from the TIF District 1-4. All members voted in favor and the motion was declared carried.
- G. CRACK FILL BIDS: At this time Crack Fill Bids were open and read. Six bids were received as shown below. Following review, a motion was made by Member Klug, seconded by Member Standish, to award the Crack Fill work to B & D Sealcoating with the apparent low bid of \$.89 per pound. All members voted in favor and the motion was declared carried.

OLD BUSINESS

A. ORDINANCE, SECTION 52.08: Clerk Nelson reviewed a proposed document for the Council to adopt as Ordinance #52.08, having to do with water supply, limiting the drilling of wells within the Municipal Limits and requiring connection to the public water system, provided it is reasonably available to a tract of land. Following explanation of the proposed ordinance, a motion was made by Member Klug and seconded by Member Standish to approve its adoption and publication. All members voted in favor and the motion was declared carried.

NEW BUSINESS

A. ANNUAL LMC CONFERENCE: Distributed with the Agenda was an announcement of the Annual LMC Conference to be held June 28 – 30 at the St. Cloud Civic Center. Clerk

Nelson asked if any Council Members were interested in attending, whereupon a motion was made by Mayor Morey, seconded by Member Vick, to authorize the attendance of any Council Members who chose to attend, approving the registration fee of \$320 for the full conference and necessary hotel costs and reimbursement of expenses. All members voted in favor and the motion was declared carried.

- B. ANIMAL CONTROL OFFICER: Referring to a petition by Mike Gavin, Animal Control Officer, at a Council Meeting held February, Mayor Morey and Member Fisch, who had since met with Mr. Gavin, recommended a change in his compensation. In addition to his past monthly wage of \$300, they recommended a \$75 increase to be paid as rental for use of his private building and reimbursement of miscellaneous expense such as use of his private vehicle. They further recommended this additional \$75 be retroactive to February 1, 2006. In addition, clarification is made that Mr. Gavin is to perform duties as a City Employee rather than a contractor. Mr. Gavin was directed to give semiannual reports to the Council. Following discussion, a motion was made by Member Klug, seconded by Member Standish, to increase the compensation of Mike Gavin, Animal Control Officer from \$300 per month to \$375 per month, the additional to represent payment for rental of his private property and reimbursement for miscellaneous expense and vehicle use, retroactive to February 1, 2006, understanding that his services are to be performed as a City Employee. All members voted in favor and the motion was declared carried.
- C. APPRAISAL COSTS: Member Fisch informed the Council that he and Mayor Morey were investigating various properties with a possible result of recommending purchase to the Council for storage of electric department and other vehicles and equipment. In order to determine an appropriate value for possible purchase, appraisals are recommended, costing up to \$3,000 per property. Following discussion, a motion was made by Member Fisch, seconded by Member Vick, to authorize expenditure of up to \$3,000 per appraisal for as many as three properties. Members voting in favor: Morey, Fisch, Vick and Standish. Opposed: Klug. The motion was declared carried.
- D. SAFE AND SOBER PROGRAM: The Council reviewed a letter from Police Chief Randy Shefelbine recommending and requesting authorization for the Caledonia Police Department to participate in a Safe and Sober Program which would be overseen by the Houston County Sheriff's Office. Officers would volunteer for duty on this program for which shifts would be appointed at times other than their normal police shifts and assign them anywhere in the County according to Sheriff's directions. Shifts would probably be no more than three times per month and four hours per shift. The program is set for the Month of May 2006. Following discussion, a motion was made by Member Standish, seconded by Member Vick, to authorize the Caledonia Police Department to participate in the Safe and Sober Program. All members voted in favor and the motion was declared carried.

CLERK'S REPORT

- A. POLICE DEPARTMENT REPORT: Enclosed with the Agenda was the Office Activity List and Officer Activity Summary for March 2006.
- B. CITY OF CALEDONIA CLEAN-UP WEEK: Enclosed with the Agenda was an announcement declaring that Spring Clean-Up would be held from Monday, April 17 thru Sunday, April 23. Following brief discussion, the Council declared by general consensus that it should be extended through Sunday, April 30.
- C. CABLE TV: Enclosed with the Agenda was a notice from Ace Communications Group that effective March 31, 2006, the Sun Dance East and Sun Dance West channel will no longer be available in the Ace Digital TV Showtime Unlimited Premium Package. Showtime has chosen not to reduce their fees to Ace Communications Group for their Showtime Unlimited Premium Package. As a result, their will not be any cost shavings past onto the customers.
- D. DISCHARGE MONITORING REPORT: Enclosed with the Agenda was the Discharge Monitoring Report for March 2006 showing the Average Monthly Total Nitrogen at 6.52 mg/l.
- E. SEMINAR: Distributed with the Agenda was announcement of a seminar Promoting Excellents in Public Management: Innovations in Cities and Counties to be held April 27 at the

Cowles Auditorium, Hubert H. Humphrey Center, U of M. Clerk Nelson said this was brought to the Councils attention in the event any of them chose to attend.

- F. ELECTRIC RATES: Clerk Nelson reported receiving a partial list of changes for the Cities wholesale rates from Tri-County Electric. Further information would follow. City rates would have to be reviewed to determine the new applicable retail rates which would be effective with May 1 usage with the first billing cycle showing the increase to be June 1.
- G. DRINKING WATER REPORT: Clerk Nelson distributed copies of notice to submit the Annual Drinking Water Report as of July 1, 2006, received from the Minnesota Department of Health.

ADJOURNMENT: There being no further business before the Council, a motion to adjourn was made by Mayor Morey and seconded by Member Klug. All members voted in favor, the motion was declared carried and the meeting then adjourned at 9:00 p.m. The next Regular Meeting of the City Council is scheduled for 7:00 p.m., Monday, April 24, 2006, in the Council Room, City Hall.
