REGULAR MEETING OF THE CITY COUNCIL CITY OF CALEDONIA, MINNESOTA Monday, September 12, 2011

CALL TO ORDER. Following due call and notice thereof, Mayor Burns called the meeting to order at 6:00 p.m. in the Council Room, City Hall.

ROLL CALL. Members present: Mayor Robert H. Burns; Council Members: Randi Vick, Tom Murphy, and Bob Lemke. Members absent: Paul Fisch. Consultants and City staff present: City Clerk/Administrator Jennifer Feely, Administrative Coordinator Mike Gerardy, City Accountant Stephanie Mann, and Shannon Sweeney with David Drown Associates. Visitors present: Caledonia Argus Reporter Charlie Warner, Matt Blocker, Houston County EDA Director Jordan Wilms, Tim Evans, Dan and Suzanne Kruse, and Dave and Kris Wedl.

AGENDA APPROVAL. A motion was made by Mayor Burns, seconded by Member Murphy, to approve the agenda with the following addition: July Ambulance Time Records. All members present voted in favor and the motion was declared carried.

CONSENT AGENDA. A motion was made by Mayor Burns, seconded by Member Lemke, to approve the consent agenda. All members present voted in favor and the motion was declared carried.

A. MINUTES OF PAST MEETINGS. To approve the minutes of the Regular Meeting held Monday, August 22, 2011 and the minutes of the Special Meeting held on September 8, 2011, as presented.

B. APPLICATION FOR EXEMPT PERMIT: CALEDONIA ROD AND GUN CLUB. To approve an application for an exempt permit for the Caledonia Rod and Gun Club at Good Times Restaurant Pizza and Bar on October 29, 2011.

VISITORS AND COMMUNICATIONS.

A. PUBLIC HEARING: SNO PAC FOODS TAX ABATEMENT. City Clerk/Administrator Feely shared that the Caledonia Economic Development Authority recommends to the City Council that a tax abatement, not to exceed \$84,000, be granted to Sno Pac Foods on a 30,000 square foot commercial building expansion. It was noted that as proposed, the total estimated amount of abatement from the City would be approximately \$7,666.50 annually, for a period of 10 years, not to exceed \$84,000.00. Mayor Burns opened the public hearing at 6:05 p.m. Hearing no comments from the public, Mayor Burns closed the meeting at 6:13 p.m. Discussion ensued. A motion was made by Member Murphy, seconded by Member Vick, to approve a tax abatement for Sno Pac Foods on a 30,000 square foot commercial building expansion at 75% per year, or approximately \$7,666.50 annually, for a period of 10 years, not to exceed \$84,000.00. All members present voted in favor and the motion was declared carried.

B. DAVE AND KRIS WEDL – GOOD TIMES RESTAURANT. Dave and Kris Wedl, owners of Good Times Restaurant, were in attendance to address the City Council. The Wedl's questioned why Section 111.31(E) of the City's Code of Ordinances requires that no license shall

be issued to any person who is not a resident of the state. Discussion ensued. The consensus of the Council is that the concern will be taken under advisement to determine what, if any, modification will be made to the language in Section 111.31(E) regarding requiring liquor license holders to be residents of the State of Minnesota. The Wedl's then inquired as to whether the City is required to perform alcohol compliance checks as they are not in favor of compliance checks. The Wedl's went on to state that they have no problem with police officers performing random checks at their restaurant and bar, however, they are not in favor of the compliance checks as a bar tender that is found guilty of selling alcohol to a minor is charged with a gross misdemeanor, fined, and placed on probation. The Wedl's further went on to state that they felt the ordinance regulating liquor in Caledonia is too strict as the bar owner can be fined heavily and have their liquor license revoked if one of their bartenders sells to a minor. Much discussion ensued. The consensus of the Council is for City Clerk/Administrator Feely to check with other cities in the Tri-State Area regarding their respective rules and regulations governing liquor license checks to determine how Caledonia's ordinance compares. In addition, the consensus of the Council is for City Clerk/Administrator Feely to find out whether liquor compliance checks are required annually. No official action was taken.

C. SHANNON SWEENEY - DAVID DROWN ASSOCIATES. City Clerk/Administrator Feely shared that given the number of infrastructure projects (Sanitary Sewer System Rehabilitation, Waste Water Treatment Plan Rehabilitation, Automatic Read Meters, and City-Wide Street Improvement Project) that the City would like to take on in the near future, it seemed appropriate to invite David Drown Associates (DDA) Financial Consultant Shannon Sweeney to attend the meeting to discuss ways in which he may be able to assist the City as its financial advisor. DDA Financial Consultant Shannon Sweeney was present to share that DDA provides the following financial services to the public sector: bond issuance, developer negotiation, TIF District creation and administration, tax abatement, capital improvement planning, special assessment structuring, business subsidy processing and more. Sweeney noted that DDA does not charge for phone calls, preparation of preliminary debt service schedules, or preliminary project discussions. Discussion then ensued regarding financing for projects through United States Department of Agriculture Rural Development (USDA RD) and Public Facilities Authority (PFA). Sweeney explained that USDA RD looks at affordability versus need whereas PFA looks at need versus affordability. It was noted that to qualify for financing through USDA RD, water and sewer rates generally have to be significantly increased to anywhere between \$40.00-\$46.00 per month. Sweeney stated that financing through PFA is more attractive as it was explained that USDA RD may offer a 40 year loan at 4.25% whereas PFA may be able to offer a 30 year loan at 1%. It was noted that on large scale projects, it may make sense to use both USDA RD and PFA. It was further noted that there may be some monies available through the Small Cities Development Program (SCDP) to offer financial relief in areas where property owners have little resources to pay for special assessments associated with infrastructure improvements. Sweeney stated that it generally takes 1-11/2 years to get through the grant application process through SCDP and that it is not an easy process. Discussion then ensued regarding establishing a special assessment policy. Sweeney pointed out that if the City obtains funding through PFA, it can still go through DDA to secure additional funding to complete a project. It was noted that the Council would like to provide its local lenders the opportunity to provide financing for projects. Sweeney pointed out that if the City gives DDA a list of projects that its working on, DDA can then provide recommendations as to appropriate rate structures, review financials, and make recommendations on areas in which to improve on, such as, say, the benefits of having a general balance of x amount of dollars and so forth. Discussion next encompassed certificates of indebtedness. Discussion also took place regarding reviewing collateral pledge sheets. Member Vick inquired as to reviewing the comprehensive plan that was

previously put together by DDA. Sweeney replied that it is a good idea for the City to review its comprehensive plan annually. Discussion ensued. No official action was taken.

D. CITY ACCOUNTANT TOPICS.

1. ADOPTION OF 2012 PRELIMINARY LEVY. City Accountant Stephanie Mann was present to review a proposed 2012 preliminary levy of \$710,636 totaling a 6.62% increase over the 2011 levy. Discussion ensued. A motion was made by Mayor Burns, seconded by Member Murphy, to approve a 2012 preliminary levy of \$710,636, a 6.62% increase over the 2011 levy, and wait for the governor's indication as to whether there will be further unallotments to Local Government Aid in 2011 or 2012. All members present voted in favor and the motion was declared carried. City Clerk/Administrator Feely stated that as per Minnesota Statutes 275.065, all cities must announce the date, time, and place of subsequent meetings at which the budget and levy will be discussed and at which public comment will be permitted. Discussion ensued. The consensus of the Council was to hold the Truth In Taxation Public Meeting on December 12, 2011 at 6:05 p.m. in the Council Chambers located at City Hall.

E. ADMINISTRATIVE COORDINATOR TOPICS.

1. DAN KRUSE ZONING. Administrative Coordinator Mike Gerardy shared that a zoning application was received from Dan and Suzanne Kruse, 705 North Hokah Street, for the purpose of constructing a 12'x24' addition onto their existing garage. Gerardy pointed out that the addition will be located approximately 7' from the south property line. Gerardy went on to point out that the proposal requires consideration of the following: (1) 3' setback variance from the south property line and (2) 1' setback variance from the recorded easement on file. It was noted that the easement is located on the south side of the property. Discussion ensued. Hearing no comments or concerns from the public, a motion was made by Mayor Burns, seconded by Member Lemke, to approve the 3' setback variance on the south property line, as the variance request is not out of the ordinary and access to the property from the other side will not be an issue, as well as grant the 1' setback variance from the recorded utility easement. All members present voted in favor and the motion was declared carried.

2. PINE STREET IMPROVEMENT. Administrative Coordinator Gerardy requested the Council's consideration in removing and reshaping the existing asphalt and curb and gutter work at the section on Pine Street between East Grove Street and East South Street. Discussion ensued. A motion was made by Member Murphy, seconded by Member Vick, to authorize spending approximately \$20,000.00 to improve the section on Pine Street that is located between East Grove Street and East South Street. Voting in Favor: Murphy, Vick, and Lemke. Voting Against: None. Abstaining: Burns. The motion was declared carried.

F. COMMUNICATIONS.

1. ARGUS SCHEDULE OF SALUTES. Attached with the agenda was a schedule of salutes from the Caledonia Argus. Discussion ensued. The consensus of the Council is to sign up for the following salutes: Veteran's Day, Fire Prevention, and Fall Sports Review.

2. MEDIACOM NOTICES. Attached with the agenda were three notices from Mediacom regarding channel changes.

3. CHAMBER OF COMMERCE BLUFF AND VALLEY BALLOON RALLY COMMITTEE LETTER. Attached with the agenda was a letter from Randy Weibel on behalf of the Bluff and Valley Balloon Rally Committee. City Clerk/Administrator Feely noted that a copy of the letter was sent to the Auxiliary Police, Ambulance, and Fire Departments for their information and review.

NEW BUSINESS.

A. ADJOURN INTO CLOSED SESSION FOR PRELIMINARY CONSIDERATION OF CHARGES AGAINST AN INDIVIDUAL SUBJET TO THE CALEDONIA CITY COUNCIL'S AUTHORITY. City Clerk/Administrator Feely stated that as per Minnesota Statutes 13D.05, subdivision 2(b), a body shall close one or more meetings for preliminary consideration of allegations or charges against an individual subject to its authority. Tim Evans waived his right to have the meeting remain open. Mayor Burns adjourned into closed session at 8: 23 p.m. and re-opened the meeting at 8: 50 p.m. A motion was made by Mayor Burns, seconded by Member Lemke, to suspend Timothy Evans without pay for one day. All members present voted in favor and the motion was declared carried. B. RESOLUTION ACCEPTING DONATION TO THE CALEDONIA LIBRARY. City Clerk/Administrator Feely shared that attached with the agenda was a resolution accepting a \$500.00 donation to the Caledonia Library from ACE Communications Group regarding a donation that Library Director Marla Burns had recently received. A motion was made by Mayor Burns, seconded by Member Murphy, to accept the \$500.00 donation from ACE Communications Group to be used to assist the Caledonia Library. All members present voted in favor and the motion was declared carried.

C. MINNESOTA PUBLIC FACILITIES AUTHORITY RESOLUTION. City Clerk/Administrator Feely shared that attached with the agenda was a resolution of application from the City of Caledonia to the Minnesota Public Facilities Authority (PFA) for a loan from the Clean Water Revolving Fund/Drinking Water Revolving Fund for improvements. It was noted that as per the City's engineer, Davy Engineering, such a resolution needs to be approved prior to submitting an application to PFA for low interest financing in conjunction with the planned sanitary sewer rehabilitation project. It was explained that the purpose of the resolution is to assure the Internal Revenue Service that expenditures in advance of the final financing are done in the anticipation that bonds will be tax exempt. It was noted that the portion of the sewer rehabilitation and lift station project that is eligible for funding is approximately \$1,684,452.00 while the non-eligible City portion totals approximately \$506,000.00. A motion was made by Mayor Burns, seconded by Member Murphy, to approve the PFA Resolution of Application. All members present voted in favor and the motion was declared carried.
