We understand that the risk of becoming exposed to or infected by COVID-19 at the Coulee Region Sports League may result from the actions, omissions, or negligence of ourselves and others, including, but not limited to the Coulee Region Sports League employees, volunteers, and program participants and their families.
INITIALS - We voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to ourselves including, but not limited to, personal injury, disability and death, illness, damage, loss, claim, liability, or expense, of any kind, that we may experience or incur in connection with our participation at the Coulee Region Sports League.
