

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/Covid-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. The Coulee Region Sports League has put in place preventative measures to reduce the spread of COVID-19; however, the Coulee Region Sports League cannot guarantee that you will not become infected with COVID-19. Further, participation could increase your risk of contracting COVID-19.

READ CAREFULLY BEFORE SIGNING – INITIAL EACH PARAGRAPH

____ INITIALS - By signing this agreement, my child(ren) and I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that we may be exposed to or infected by COVID-19 by participation; and that such exposure or infection may result in personal injury, illness, permanent disability, and death. We understand that the risk of becoming exposed to or infected by COVID-19 at the Coulee Region Sports League may result from the actions, omissions, or negligence of ourselves and others, including, but not limited to the Coulee Region Sports League employees, volunteers, and program participants and their families.

____ INITIALS - We voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to ourselves including, but not limited to, personal injury, disability and death, illness, damage, loss, claim, liability, or expense, of any kind, that we may experience or incur in connection with our participation at the Coulee Region Sports League. On our behalf, we hereby release, covenant not to sue, discharge, and hold harmless the Coulee Region Sports League, its employees, agents and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. We understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Coulee Region Sports League, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during or after participation in games at the Coulee Region Sports League.

____ INITIALS – We acknowledge that we have adequate insurance to cover any injury or illness we may suffer or cause while participating in this activity, or else we agree to bear the costs of such injury or illness to ourselves. We further acknowledge that we have no medical or physical condition which could interfere with our safety in this activity, or else we are willing to assume – and bear the costs of – all risks that may be created, directly or indirectly, by any such condition.

____ INITIALS – In the event that we file a lawsuit, we agree to do so in the state where the Coulee Region Sports League is located, and we further agree that the substantive law of that state shall apply. We agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

____ INITIALS – By signing this document, we agree that if we are exposed or infected by COVID-19 during our participation in this activity, then we may be found by a court of law to have waived our rights to maintain a lawsuit against the parties being released on the basis of any claim for negligence.

____ INITIALS – If we have signed a separate general waiver of liability connected at the Coulee Region Sports League, we agree that the terms of that waiver are wholly incorporated into this document and that the terms of this document are incorporated into the separate general waiver.

____ INITIALS – We agree that we will not attend Coulee Region Sports League activities if we have experienced any COVID-19 symptoms in the last 24 hours.

____ INITIALS – We accept that our child(ren) will be sent home from Coulee Region Sports League activities if he/she has a temperature above 100.3 degrees, or if he/she is experiencing any other symptoms.

____ INITIALS – We agree that we will practice safe social distancing and clean hygiene during our participation in athletics at the Coulee Region Sports League and will follow all safety guidelines the Coulee Region Sports League has put in place.

____ INITIALS – We have had sufficient time to read this entire document and, should we choose to do so, consult with legal counsel prior to signing. Also, we understand that this activity will not be made available to us if we were to choose not to sign this release. We have read and understood this document and we agree to be bound by its terms.
