REGULAR MEETING OF THE CALEDONIA CITY COUNCIL CITY COUNCIL CHAMBERS, CITY HALL CALEDONIA, MINNESOTA Monday, October 9, 2017

CALL TO ORDER: Following due call and notice thereof, Mayor Schroeder called the meeting to order at 6:00 p.m. in the Council Chambers of City Hall.

PLEDGE OF ALLEGIANCE: Mayor Schroeder led the Council, City staff, and visitors in stating the Pledge of Allegiance.

ROLL CALL: Council members present: Mayor DeWayne "Tank" Schroeder, Robert Burns, and Robert Lemke. Council member(s) absent: Paul Fisch and Randi Vick. City staff present: Casey Klug, public works and zoning director; Adam Swann, clerk-administrator. Visitor(s) present: Gary Becker; Gordon Becker; Henry Becker; Donald Burroughs, Jr.; Yin Chiao; Michael Davy, Davy Engineering; George Kittleson; Randall Mann; Mouse Meyer; Craig Moorhead, *Caledonia Argus*; Dave Olson; Jim Olson; Marion Olson; Dave Rask; Mike Rogich; Irvin Rottman; Shar Schroeder; Dan Schwirtz; and Jeff Wild.

CONSENT AGENDA: Member Burns moved to approve the consent agenda provided that i) the Operating Engineers Local #49 Health and Welfare Fund Public Sector Participation Agreement for Non-Bargaining Premium Employees was removed from the consent agenda and ii) Resolution 2017-009 was corrected to reflect that the City-maintained paths on Minnesota State Highway 44/76 were between W. Main St. and Esch Dr. and Esch Dr. and North Park. Member Lemke seconded the motion. All members present voted in favor of the motion, and the motion passed. The consent agenda comprised the following items:

- a. Approval of minutes from September 25, 2017 regular meeting
- b. Authorization to hire Crystal M. Ostern as part-time clerk at Municipal Liquor Store at wage of \$9.50/hr.

PUBLIC COMMENT: None.

CLERK-ADMINISTRATOR:

a. Updates

i. <u>Negotiations with Local 49</u>: Swann reported that he, Councilmember Burns, and Councilmember Fisch had a second meeting with the International Union of Operating Engineers Local 49 and union stewards on October 3, 2017 to continue negotiations on a new collective bargaining agreement. Swann reported that the City and union were making progress.

ii. <u>Negotiations with Law Enforcement Labor Services</u>: Swann reported that the City had received notification from Law Enforcement Labor Services that they wanted to proceed with negotiating a collective bargaining agreement for the City's law enforcement officers. The consensus of the Council was that Councilmember Burns and Councilmember Fisch should serve as the Council's representatives for negotiations since they had been negotiating the collective bargaining agreement with the International Union of Operating Engineers Local 49.

iii. <u>N. Kingston St. Reconstruction Project</u>: Swann reported that he and Public Works and Zoning Director Casey Klug had met with WSB & Associates to obtain a second proposal for engineering services for the N. Kingston St. Reconstruction Project. Swann reported that they requested the second proposal to compare the engineer costs and determine if it would be possible to put the project out for bid by early January 2018. Swann expected to get the proposal by the next Council meeting.

iv. <u>Boilers and Heat Exchanger at Wastewater Treatment Plant</u>: Swann reported that the City had signed a proposal from Winona Controls to install a new heat exchanger and replace the boiler at the wastewater treatment plant with two (2) natural gas boilers for a cost of \$72,850. Swann reported that the City tried getting more than one quote for the work, but Winona Controls was the only contractor that responded.

NEW BUSINESS:

a. <u>Public hearing re public improvement project on E. South St. and S. First St.</u>: At 6:05 p.m. the regular meeting was adjourned to hold a public hearing on a proposed public improvement project that would extend sanitary sewer service to 19 properties on East South Street and South First Street and would extend water service to 5 properties on South First Street. The 19 properties that would receive access to sanitary sewer service had the following parcel IDs: 210381000, 210388001, 210392000, 210396000, 210452002, 210438000, 210445000, 210447000, 210452000, 210453000, 211094000, 211095000, 210382000, 210383000, 210383001, 210389000, 210390000, 210391000, and 210391001. The 5 properties that would receive access to water service had the following parcel IDs: 210383001, 210383000, 210383001, 210391000, and 210391000. The estimated project cost for extending sewer service was \$349,870, and under the proposal the 19 affected property owners would be assessed 25% of this cost, which equaled \$4,603.55 per parcel. The estimated project cost for extending water service was \$38,170, and under the proposal the 5 affected property owners would be assessed 25% of this cost, which equaled \$4,603.55 per parcel. Property owners would have 30 years to pay their assessments, and the City would not charge interest.

Michael Davy of Davy Engineering started the public hearing by explaining the proposed public improvement project and discussing the proposed assessment. Davy described the design of the proposed sewer extension. Davy reported that the City's proposal to pay for 75% of the public improvement project and to allow property owners to pay their assessments over 30 years at 0% interest was very generous based on his experience. Davy explained that the public improvement hearing was the first step and that the City would have another hearing to formally approve the assessments if the project moved forward. Davy answered questions from the public. Davy reported that the City had not yet selected a location for a lift station on E. South St. and that the City would probably need to purchase a 50' x 50' parcel for this purpose.

Members of the public asked questions about the project and spoke both in favor of and against the project. Mayor Schroeder took a poll of the property owners in attendance (by asking them to raise their hands) as to whether they supported or opposed the project. Of the 19 parcels impacted by the proposed sewer extension, 10 parcel owners supported the sewer extension, and 4 parcel owners opposed the sewer extension; 5 parcel owners were not present. Of the 5 parcels impacted by the proposed water extension, 2 parcel owners supported the water extension, and no parcel owners opposed the water extension; 3 parcel owners were not present.

At 7:02 p.m. the public hearing was closed, and the regular meeting of the City Council was reconvened.

b. <u>Consideration of Resolution 2017-010:</u> A Resolution Ordering Public Improvement Project on E. <u>South St. and S. First St.</u>: No action was taken by Council on the proposed resolution.

c. <u>Review of Proposed Well Site at Sunnyside Park</u>: Council reviewed a map/site layout for a new well in Sunnyside Park. Michael Davy of Davy Engineering reported that Sunnyside Park would be a good site for a new City well; there were no reports of contamination in the area. Davy reported that the

Minnesota Department of Health would have to perform a site inspection before the site could be approved for a well; Davy noted that once the site was approved, the City would still need to get a well plan approved before the City could drill a well. Member Burns moved to have Davy Engineering continue with the water project by getting the information necessary and coordinating with the State of Minnesota as necessary to move forward with the project. Mayor Schroeder seconded the motion. All members present voted in favor of the motion, and the motion passed.

d. <u>Overtime report</u>: Members reviewed the overtime report for the pay period September 11-24, 2017. No further action was taken by the Council.

e. <u>Prepaid claims</u>: Members reviewed the prepaid claims for the period September 13, 2017 – October 6, 2017. Member Burns moved to approve the prepaid claims listed below. The motion was seconded by Mayor Schroeder. All members present voted in favor of the motion, and the motion passed.
