REGULAR MEETING OF THE CALEDONIA CITY COUNCIL CITY COUNCIL CHAMBERS, CITY HALL CALEDONIA, MINNESOTA Monday, March 14, 2016

CALL TO ORDER: Following due call and notice thereof, Mayor Gran called the meeting to order at 6:00 p.m. in the Council Room of City Hall.

PLEDGE OF ALLEGIANCE: Mayor Gran led the Council, City staff, and visitors in stating the Pledge of Allegiance. ROLL CALL: Council members present: Mayor Joshua Gran, Bob Burns, Paul Fisch, Bob Lemke, and DeWayne Schroeder. City staff present: Mike Gerardy, administrative coordinator; Adam Swann, clerk-administrator. Visitors present: Rick Frank, Houston County environmental services director; Brian Krambeer, president and CEO of Tri-County Electric Cooperative; and Steven Peplinski.

AGENDA: Motion by Member Fisch to approve the agenda; second by Member Burns. All members voted in favor to approve the agenda.

CONSENT AGENDA APPROVAL: Member Burns moved to approve the consent agenda, which comprised the following items:

- a. Matt Schuldt, Founders Day Committee: Schuldt addressed the Council about plans for Founders Day on Saturday, June 18, 2016.
- b. Rick Frank, Houston County environmental services director: Frank discussed with Council the Houston County Environmental Services' income and expenses in 2015 for its recycling, trash disposal, and household hazardous waste services. Frank reported on Houston County Environmental Services' recycling, trash disposal, and household hazardous waste services for the City of Caledonia.
- c. Brian Krambeer, president & CEO, Tri-County Electric Cooperative: Krambeer discussed with Council the proposed merger between Hawkeye REC and Tri-County Electric Cooperative.

PUBLIC COMMENT: None.

NEW BUSINESS:

- a. Closure of City streets and waiver of noise ordinance for Founders Day: Member Burns moved the following to support Founder's Day celebrations: 1) to close two blocks of Main St. from Kingston St. to Pine St. and two blocks of Marshall St. from E. Lincoln St. to E. Grove St. on June 18, 2016 from 9:00 a.m. to 1:00 a.m. on June 19, 2016; and 2) to authorize the Founder's Day musicians to play from 10:00 p.m. on June 18, 2016 to 1:00 a.m. on June 19, 2016; and 3) to provide access to City electrical outlets. Member Schroeder seconded the motion. All members present voted in favor of the motion, and the motion passed.
- b. <u>Authorization to transfer \$2,998 allocated in City budget for EDA contracted labor and services to EDA fund</u>: Member Burns moved to transfer \$2,998 allocated in City budget for Caledonia EDA contracted labor and services to EDA to balance the net fund income for the Caledonia Intermediary Revolving Loan program. Member Fisch seconded the motion. All members present voted in favor of the motion, and the motion passed.
- c. Authorization to transfer \$50,000 from general fund to Caledonia EDA for provision of loans to businesses in Downtown Caledonia: Member Burns moved to authorize the City to loan the Caledonia EDA up to \$50,000 at 1% for the provision of loans to downtown businesses on an as-needed business to be used as gap financing and not to exceed \$30,000— and loaned at a tiered interest rate based on the purpose of the of the loan. The money would be transferred to the EDA as needed and would be returned to the City's general fund when paid back and would not be a revolving loan fund. Member Schroeder seconded the motion. Roll call vote: Lemke: Yes, Burns: Yes, Gran: No, Schroeder: Yes, Fisch, Yes. Motion passed 4-1.
- d. <u>Approval of City's participation in Houston County annual florescent/HID light bulb disposal program</u>: Member Burns moved that the City participate in Houston County's annual florescent/HID light bulb disposal program by paying for the first 10 bulbs for each person or business. Member Fisch seconded the motion. All members present voted in favor of the motion, and the motion passed.
- e. <u>City's position regarding merger proposed merger of Hawkeye REC and Tri-County Electric Cooperative</u>: Member Gran moved that the City vote in favor of the proposed merger between Hawkeye REC and Tri-County Electric Cooperative. Member Burns seconded the motion. All members present voted in favor of the motion, and the motion passed.

- f. Resolution 16-001: A resolution authorizing a joint powers agreement between the City of Caledonia and the State of Minnesota: Member Fisch moved to approve Resolution 2016-001: A Resolution Authorizing Execution of a Joint Powers Agreement Between the City of Caledonia, Minnesota and the State of Minnesota, Acting through its Department of Public Safety and the Bureau of Criminal Apprehension. Motion seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.
- g. Resolution 16-002: A resolution authorizing an amendment to the joint powers agreement between the City of Caledonia and the State of Minnesota: Member Fisch moved to approve Resolution 2016-002: A Resolution Authorizing Execution of a Court Data Services Subscriber Amendment to the Minnesota Criminal Justice Data Communications Network (CJDN) Subscriber Agreement. Motion seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.
- h. <u>Approval of auditorium key requests</u>: Mayor Gran moved to approve key requests from ABLE, Inc.; Marla Burns; Patrick Doyle; Jon Hagerott; Joe Horihan; Brad King; Randy King; Kevin Klug; Philip Klug; Dan Kruse; Joel Linstrom; Don Meiners; Lynn Meiners; and Helen Olson. Motion seconded by Member Burns. All members present voted in favor of the motion, and the motion passed.
- i. <u>Authorization to budget \$2,000 for hiring of assistant for summer recreation program director</u>: Member Burns moved to add \$2,000 to City budget for athletic field wages to hire assistant for summer recreation program director. Motion seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.
- j. <u>Authorization to hire Jordyn Krause as emergency medical responder</u>: Council reviewed recommendation form Mike Tornstorm, director of the Ambulance Department, to hire Jordyn Krause as an emergency medical responder. Member Burns moved to approve the hiring of Jordyn Krause as an emergency medical responder for the City's Ambulance Department. Motion was seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.
