REGULAR MEETING OF THE CALEDONIA CITY COUNCIL CITY COUNCIL CHAMBERS, CITY HALL CALEDONIA, MINNESOTA Monday, July 11, 2016

CALL TO ORDER: Following due call and notice thereof, Mayor Gran called the meeting to order at 6:00 p.m. in the Council Room of City Hall.

PLEDGE OF ALLEGIANCE: Mayor Gran led the Council, City staff, and visitors in stating the Pledge of Allegiance.

ROLL CALL: Council members present: Mayor Joshua Gran, Robert Burns, Paul Fisch, Robert Lemke, and DeWayne Schroeder. City staff present: Mary Betz, assistant ambulance director; Mike Gerardy, administrative coordinator; Mark Schiltz; Adam Swann, clerk-administrator; Mike Tornstrom, ambulance director.

AGENDA: Swann asked Council to add the following item to the agenda: a request to close part of N. Marshal St. for National Night Out on August 2, 2016. Member Lemke moved to approve the agenda with the amendment; the motion was seconded by Member Fisch. All members present voted in favor to approve the agenda with the amendment.

CONSENT AGENDA APPROVAL: Member Lemke moved to approve the consent agenda. Member Fisch seconded the motion. All members present voted in favor to approve the consent agenda, and the motion was passed. The consent agenda comprised the following items:

- a. Approval of minutes for June 27, 2016 regular meeting
- b. Approval of ambulance subsidy contract between the City of Caledonia and Caledonia Township
- c. Approval of ambulance subsidy contract between the City of Caledonia and Crooked Creek Township
- d. Approval of destruction orders for weeds, grasses, and rank vegetation
- e. Approval of application from St. Mary's Church/School to hold gambling activity on October 30, 2016

PUBLIC COMMENT: None.

PRESENTATIONS:

a. Mike Tornstrom, director, and Mary Betz, assistant director of the Caledonia Ambulance Department, reported on the changes that had been made since November 2015 to improve staffing of EMTs, including increasing pay for on-call time and hiring in-house EMTs during the day—as well as offering an EMT training class, which recently added 6 new EMTs to the department. Mr. Tornstrom and Ms. Betz also discussed the requirements for becoming an EMR and EMT. They also reported on the City's mutual aid agreement with Spring Grove.

ADMINISTRATIVE COORDINATOR:

a. <u>Maintenance projects</u>: Gerardy requested Council approval to hire B&D Sealcoating to clean, repair, and seal the asphalt on the City parking lot near the police station and two areas of the walking path along Hwy 44/76 for \$6,850. Member Fisch moved to approve the work, and the motion was seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.

b. <u>Pool construction</u>: Gerardy updated Council on the progress of the pool construction.

UNFINISHED BUSINESS: None.

NEW BUSINESS:

a. <u>Ordinance 2016-002</u>: Ordinance Regulating Nonessential Water Usage Upon Critical Water <u>Deficiency as Mandated by Minn. Statute § 103G.291, subd. 1 and 2</u>: Council reviewed and discussed Ordinance 2016-002, which would restrict use of water from public water sources when the governor declared a critical water deficiency. Gerardy advised Council that the ordinance was required as part of the City's 10-year Water Supply Plan, which was approved by the Minnesota Department of Natural Resources earlier in the year. Member Burns moved to approve Ordinance 2016-002, and the motion was seconded by Member Fisch. All members present voted in favor of the motion, and the motion passed.

b. <u>Resolution 2016-009</u>: <u>Resolution Appointing Election Judges for Primary Election on August 9,</u> 2016: Member Burns moved to approve Resolution 2016-009. The motion was seconded by Member Fisch. All members present voted in favor of the motion, and the motion passed.

c. <u>Resolution 2016-010</u>: <u>Resolution Approving Clerk-Administrator's Exclusion from PERA</u> <u>Coordinated Plan</u>: Member Burns moved to approve Resolution 2016-010, and the motion was seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.

d. <u>Authorization to hire Megan Bulman, Sarah Kruckow, and Rachel Meyer as EMTs</u>: Council reviewed a recommendation from Ambulance Director Tornstrom to hire Megan Bulman, Sarah Kruckow, and Rachel Meyer as emergency medical technicians in the Ambulance Department. Member Burns moved to approve the hiring of Bulman, Kruckow, and Meyer, and the motion was seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.

e. <u>Overtime report</u>: Council reviewed the overtime report for City employees for the pay period June 20-July 3, 2016. No further action was taken by the Council.

f. <u>Prepaid claims</u>: Council reviewed the prepaid claims for the period June 20, 2016 through July 3, 2016. Member Burns moved to approve the prepaid claims listed below. The motion was seconded by Member Lemke. All members present voted in favor of the motion, and the motion passed.
