ORDINANCE NO. 2026-01

**AN ORDINANCE AMENDING TITLE XI CHAPTER 111 OF THE CITY CODE
REGULATING ALCOHOLIC BEVERAGES**

THE CITY COUNCIL OF THE CITY OF CALEDONIA HEREBY ORDAINS AS FOLLOWS:

SECTION 1. AMENDMENT. City Code Title XI Chapter 111 is amended as follows:

ALCOHOLIC BEVERAGES

111.25 (B) *Financial Responsibility*. Prior to the issuance of a liquor license, the applicant shall file with the city clerk a liability insurance policy in the amount of one million dollars (\$1,000,000.00) coverage for one or more persons and shall comply with the provisions of Minnesota statutes section 340A.409 relating to liability insurance policies. Operation of a business which is required to be licensed by this chapter without having on file with the city at all times effective proof of financial responsibility is a cause for revocation of the license.

SECTION 2. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage and publications as required by law.

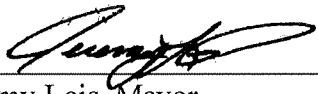

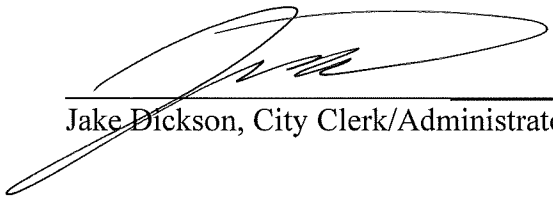
AN ORDINANCE AMENDING TITLE XI CHAPTER 111 OF THE CITY

The above-referenced Ordinance amends the Caledonia City Code Title XI –Chapter 111 regulating alcoholic beverages within the City. 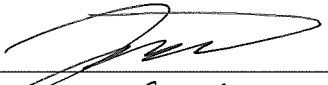
