REGULAR MEETING OF THE CITY COUNCIL CITY OF CALEDONIA, MINNESOTA Monday, April 15, 2015

CALL TO ORDER: Following due call and notice thereof, Mayor Gran called the meeting to order at 6:00 p.m. in the Council Room, City Hall.

ROLL CALL: Members present: Mayor Joshua Gran, Council Members: DeWayne Schroeder, Bob Lemke, Bob Burns and Paul Fisch. City Staff Present: City Clerk/Administrator Ted Schoonover, Smith, & Schafer Associates member Thomas Wente, Caledonia Argus reporter: Zachary Olson, Guests: Marge Birkeland, Mary Pieper, DeAnna McCabe, Steve Reiman, Mary Mell, Dan Kruse, Carolyn Medin, Terry Lauden, Laurel Rusert and Norman Snodgrass.

AGENDA: Motion by Member Burns, second by Member Lemke to approve the agenda. All present voted in favor and the motion was declared carried.

CONSENT AGENDA APPROVAL: Motion by Mayor Gran, second by Member Fisch to approve the consent agenda, which consisted of the regular meeting minutes from the March 23, 2015 regular meeting. All members present voted in favor and the motion was declared carried.

VISITORS AND COMMUNICATIONS: None.

CITY CLERK/ADMINISTRATOR: Tom Wente was present and went through a brief overview of the 2014 Annual Audit with the City Council. He made the comment that it is not very often that a city can go through an entire year without having to do a Journal Entry to make a correction, this is proof that the staff is doing what they are supposed to do. There were no deficiencies or comments that needed to be addressed and overall the city is in a great position. Motion by Member Burns, second by Member Schroeder to accept the 2014 Annual Audit. All members present voted in favor and the motion was declared carried.

Norman Snodgrass was present and asked the Council to consider waiving the charge for him to pay for the new meters he installed in his apartment complex. He took out 12 of our older auto read meters and replaced them with his own meters that he will sub-meter the usage and bill the tenants. Currently the city is asking to pay \$952.00 for the new meters they had to order. Consensus of the council was to see how much the older meters would be worth and compare it to what we are charging. This should be brought back on the 27th. No action taken.

Motion by Member Schroeder, second by Member Fisch to approve the purchase of the back flow preventer for the Auditorium boilers. All members present voted in favor and the motion was declared carried.

Motion by Member Schroeder, second by Member Burns to approve the Right-of-way Easement between the City of Caledonia and Dairyland Power. All members present voted in favor and the motion was declared carried.

Motion by Mayor Gran, second by Member Burns to set a public hearing for April 27, 2015 at 6:15 p.m. to consider several variances for the new Kwik Trip Store being designed. All members present voted in favor and the motion was declared carried.

Schoonover presented the council with a proposal from DSG to purchase 2 new auto read hand held radios, the current ones are no longer being supported and one is not operational. Consensus of the council was to wait and purchase them when we needed them. No action taken.

Schoonover then presented the council with a proposal for a new Liquor Store sign. Mayor Gran and Member Burns thought that maybe we could light up the front of the building somehow a lot cheaper. Schoonover and Gerardy would look into it and report back.

Schoonover presented the council with a recommendation to hire Gary Bubbers, Ken Van Minsel and Dean Schutte to run and maintain the diseased tree site. They would rotate duties and shifts. Motion by Member Burns, second by Member Schroeder to approve the hiring of all three of them. All members present voted in favor and the motion was declared carried.

Mayor Gran then began by giving an update to the new pool and how he felt we needed to move forward. Several of the guests wanted to have the support of the City Council as they felt that would show the residents that we need a new facility. Mayor Gran and Member Burns both stated that our support has never been a negative one, but the residents overwhelmingly voted against the last referendum and we need to ensure we have their support moving forward and because we have downsized the project to 1 million dollars they both feel that we now can gather more support. Mayor Gran stated he would like to see a public forum to help educate the voters before we set up a special election. Member Schroeder stated that he is not against building a pool, he just questions how we are going to afford to pay for it once it's operational, but he too agrees that one is needed. Mayor Gran then asked Administrator Schoonover if there were any other options. Schoonover explained that we could use a tax in lieu of method to pay for the bond. He stated that most cities that implement that method use approximately 5-6% of the gross revenues from the electrical fund. In our situation we could transfer \$150,000 annually, of that \$75,000 would pay for the bond and the remaining funds could be used for other capital projects such as paving streets, purchasing

a new well site, etc... He then stated he would recommend that if we consider this option that we still move forward with the referendum. His explanation for that would be if something came up over the life of the bond we could always revert back and assess the residents if needed, so this would be a safety net per se. Several of the audience members commented that we needed pool lighting and other amenities to make it better for all. Mayor Gran and Member Burns explained that all that would be worked out after the bid letting. Mayor then stated he would set up a public forum for April 23, 2015 at 6:30 p.m. in the City Auditorium to gather input from the residents. No action taken.

Motion by Member Fisch, second by Member Lemke to approve the claim payable. All members present voted in favor and the motion was declared carried.

Schoonover presented the employee overtime report and the police April shift report. No action taken.
