**RESOLUTION 2020-01**

**RESOLUTION APPOINTING ELECTION JUDGES  
FOR PRESIDENTIAL PRIMARY ON MARCH 3, 2020**

**WHEREAS**, a presidential primary will be held in the City of Caledonia on March 3, 2020; and

**WHEREAS**, Minnesota Statute § 204B.21, subdivision 2, requires election judges for precincts in a municipality to be appointed by the governing body of the municipality; and

**WHEREAS**, the City of Caledonia has two voting precincts; and
