RESOLUTION APPOINTING ELECTION JUDGES  
FOR GENERAL ELECTION ON NOVEMBER 3, 2020

**WHEREAS**, a general election will be held in the City of Caledonia on November 3, 2020; and

**WHEREAS**, Minnesota Statute § 204B.21, subdivision 2, requires election judges for precincts in a municipality to be appointed by the governing body of the municipality; and

**WHEREAS**, the City of Caledonia has two voting precincts; and

**WHEREAS**, the following Minnesota residents have agreed to serve as election judges and have met the qualifications established by the State of Minnesota:

Precinct Two



**ADOPTED** by the Caledonia City Council this 12<sup>th</sup> day of October, 2020.


