**RESOLUTION 2021-11**

**A RESOLUTION SUPPORTING MIKEN SPORTS' EMPLOYEES AND OPERATIONS  
IN CALEDONIA AND URGING RAWLINGS SPORTING GOODS TO REVERSE ITS  
DECISION TO CLOSE MIKEN SPORTS**

**WHEREAS**, Miken Sports has maintained an office and manufacturing facility in the City of Caledonia since 1999; and

**WHEREAS**, Miken Sports has been one of the City's top employers for many years; and

**WHEREAS**, in mid-March 2020, at the beginning of the COVID-19 pandemic, Miken Sports employed 127 personnel in Caledonia; and

**WHEREAS**, as of July 22, 2021, Miken Sports employed approximately 78 personnel in Caledonia; and

**WHEREAS**, Miken Sports has been an excellent community partner for many years, providing donations and other support to youth sports teams and participating in various community events; and

**WHEREAS**, Miken Sports employees are valued members of the Caledonia community and have contributed significant amounts of time, money, and resources to improving the Caledonia community; and

**WHEREAS**, Caledonia is proud to be the home of Miken Sports and proud to manufacture the helmets used by Major League Baseball; and

**WHEREAS**, Miken Sports employees are talented, hard-working individuals; and

**WHEREAS**, despite the dedicated service of these employees to Miken Sports, the owner of Miken Sports, Rawlings Sporting Goods Co., Inc. ("Rawlings Sporting Goods"), has announced that it will be closing the Miken Sports office and manufacturing facility in Caledonia in 18-24 months; and

**WHEREAS**, Rawlings Sporting Goods will be sending most of these jobs to a factory in China; and

**WHEREAS**, Major League Baseball and the Seidler Equity Partners jointly own Rawlings Sporting Goods; and

**WHEREAS**, Major League Baseball had revenues of \$10.37 billion in 2019 prior to the pandemic and revenues of \$3.66 billion in 2020 during the pandemic; and

**WHEREAS**, Major League Baseball has received billions of dollars in public assistance in the United States; and

**WHEREAS**, 27 of the 30 Major League Baseball teams play in stadiums constructed with publicly financed loans or taxes; and

**WHEREAS**, Target Field in Minneapolis was constructed using \$350 million in public funds from a Hennepin County sales tax; and

**WHEREAS**, the four-plus million dollars per year that Rawlings Sporting Goods claims it will save from outsourcing the Miken Sports jobs to China is a small fraction of the funds it has received from U.S. taxpayers and is miniscule when compared with its \$10 billion in revenues per year; and

**WHEREAS**, Major League Baseball markets itself as “America’s Favorite Pastime,” including when it lobbied Congress to pass the Save America’s Pastime Act in 2018; and

**WHEREAS**, Major League Baseball and Seidler Equity Partners’ decision to outsource American jobs is incompatible with the idea of baseball being America’s favorite pastime; and

**WHEREAS**, the COVID-19 pandemic has demonstrated the importance of manufacturing goods in the United States; and

**WHEREAS**, moving Miken Sports’ bat production to China punishes Caledonia’s workers for the benefit of a country that routinely steals intellectual property and violates human rights; and

**WHEREAS**, outsourcing Caledonia’s jobs to China shortly after the COVID-19 pandemic is even more offensive given that China was the source of the COVID-19 pandemic and refused to cooperate with international and governmental officials to prevent the spread and impact of the pandemic, thereby significantly exacerbating the economic and human toll of the virus; and

**WHEREAS**, Major League Baseball has demonstrated recently that it will make decisions based on political considerations—and not just monetary ones—when it moved the 2021 All-Star game from Atlanta to Denver to protest what it claimed was Georgia legislation suppressing voting rights; and

**WHEREAS**, China has been actively suppressing pro-democracy demonstrators in Hong Kong since 2020 and denies all Chinese the opportunity to participate in free and fair elections; and

**WHEREAS**, moving Caledonia’s jobs to China would be inconsistent with Major League Baseball’s purported support for democracy and voting rights.

**NOW, THEREFORE, THE FOLLOWING IS HEREBY RESOLVED BY THE CALEDONIA CITY COUNCIL:**

1. The City of Caledonia supports the talented, hard-working employees of Miken Sports and appreciates the contributions Miken Sports and its employees have made to the City for more than 20 years.

2. The City of Caledonia opposes any efforts to outsource Caledonia's jobs to China, especially when Major League Baseball is supposed to be America's favorite pastime and has benefited significantly from public assistance from American taxpayers.


3. The City of Caledonia further opposes any efforts to outsource Caledonia's jobs to China because of China's record of stealing intellectual property, violating human rights, and exacerbating the impact of the COVID-19 pandemic.

4. The City of Caledonia urges Major League Baseball and the Seidler Equity Partners to reverse their decision to close Miken Sports in 18-24 months.


5. The City of Caledonia further urges Major League Baseball to stand by its commitment to protecting democracy and voting rights by not exporting American jobs to China.
