**RESOLUTION 2021-19**

**A RESOLUTION AUTHORIZING THE CITY OF CALEDONIA  
TO ACCEPT SUPPLEMENTAL PROCEEDS FROM THE CORONAVIRUS LOCAL  
FISCAL RECOVERY FUND ESTABLISHED UNDER THE AMERICAN RESCUE  
PLAN ACT**

**WHEREAS**, Congress adopted the American Rescue Plan Act (“ARPA”) in March 2021, which included \$65 billion in recovery funds for cities across the country; and

**WHEREAS**, the City of Caledonia (“City”) was initially allocated approximately \$291,294.93 in ARPA funds based on a population of 2,753 (using 2019 Census data) and a per capita distribution of \$105.81; and

**WHEREAS**, the City Council previously voted to request and accept its initial allocation of ARPA funds on August 9, 2021; and

**WHEREAS**, some local governments in Minnesota did not submit a request for their share of the \$377 million available to Minnesota’s non-entitlement cities, leaving nearly \$12 million unrequested; and

**WHEREAS**, the State of Minnesota, as authorized by the United States Treasury Department, has reallocated the \$12 million to eligible local governments who requested ARPA funds, and these funds are being paid in the form of supplemental ARPA payments; and

**WHEREAS**, these supplemental distributions equal approximately \$3.47 per capita; and

**WHEREAS**, the City is eligible for these supplemental ARPA payments; and

**WHEREAS**, the City received the first half of its supplemental distribution on November 22, 2021, in the form of a deposit of \$4,769.87; and

**WHEREAS**, the City will receive the second half of its supplemental distribution—another \$4,769.87—in August 2022 when it receives the second half of its original allocation of \$291,294.93 in ARPA funds; and

**WHEREAS**, the City, in response to the Pandemic, has had expenditures and anticipates future expenditures consistent with the Department of Treasury’s ARPA guidance.


**NOW, THEREFORE, THE FOLLOWING IS HEREBY RESOLVED BY THE  
CALEDONIA CITY COUNCIL:**

1. The City of Caledonia intends to collect its share of supplemental ARPA funds from the State of Minnesota to use in a manner consistent with the Department of Treasury’s guidance.


2. The City of Caledonia mayor and City employees are hereby authorized to accept the City's share of supplemental ARPA funds from the State of Minnesota.

3. The City of Caledonia mayor and City employees are hereby authorized to make recommendations to the City Council for future expenditures that may be reimbursed with the supplemental ARPA funds.
